## Chairman's Message

Dear Friends,

Corona tragedy that hit the world in early 2020 still continues to haunt the mankind. As elaborated in my message last year, MFT had taken a number of steps to mitigate the suffering to the extent feasible and many of these steps and initiatives have continued to this date, with many additional schemes having been launched and implemented expeditiously.

Very cruel and insurmountable second wave literally led to a complete, countrywide break-down of all health and administrative infrastructure with a large number of families losing family members, breadwinners etc. I do not believe our country has ever seen such devastation!

Instead of lamenting over the situation, we launched a number of additional support schemes. One of the most important schemes was to identify families that had lost their only bread-winner to COVID and start immediate monthly cash assistance of Rs 3,000 pm, along with adequate ration kits (depending on number of members in the family etc.). It was a long time before state and central governments announced their own assistance packages. We then ensured that these beneficiaries got registered under appropriate schemes. Over hundred families were covered under this unique Sustainable Support Initiative.

Extensive assistance was also rendered to the relatives of the patients who had no other support system (admitted at Samras and other hospitals). Ration kits were very generously distributed to all needy families. In addition, given that all class rooms were working in virtual mode, a large number of smart phones, laptops and PCs were provided so that the education of the students from the under-privileged sections of our society did not suffer.

In terms of our regular Educational initiatives, we could continue Kayakalp initiative in full steam while ADMS was also run in virtual mode. Asha Deep centers had to be shut down and Open Scholarship and Adopted Schools were handled virtually. We could still manage to largely reach all our beneficiaries; the continuity was only marginally impacted and all financial assistance indeed reached the target group. Of course, our flagship events of Annual Cultural Evening and Sports Day had to be kept on hold!

I sincerely hope that humanity never sees such times again. While now we are literally in expansion mode, we do hope that the sufferings go away and good times are back again for all our beneficiaries as also the entire humanity!

On a closing note, I am gratified to note that financial support from all our benefactors has continued unabated!

#### **Education and Compassion** Hallmarks of our Initiatives

Mahavir International, Vadodara Kendra is a collective of some of the leading citizens of Vadodara who have excelled in life and who have been working to return something to society through upliftment of weaker sections of society. The group include accomplished professionals from all walks of life -all dedicated to the cause and willing to contribute both time and money. Our focus has been on Quality Education of students from economically weaker sections of our society. We currently support around 6,000 students and spend approx Rs. 2.5 crores annually through various schemes - from Street Schools to University Education.

We strongly believe that better education is the most potent way of upliftment of such families and for reducing disparities in society, which could lead to a better India.

Since its inception, MFT has strictly adhered to the five Guiding Principles viz. Personal assessment of beneficiaries through house visits, No religion, caste or gender-based Discrimination, Continuity of Support, No administrative expenses (admin expenses being met directly by members) and upholding Self-respect of beneficiaries.

## **Adopted Schools Initiative**

Adopted Schools initiative was started in 2001 and has continued ever since. Schools catering to students from socioeconomically weaker sections of our society are covered under this initiative. Most of the selected schools are at High / Higher Secondary level and have been part of this initiative for almost twenty years now. As an example of the type of students, a large number of girl students from these schools partly help their mothers who are house-maids and even substitute for them, when necessary!

The initiative currently focuses on ten schools. Generally, prizes and scholarships are given at a specially organized function at each school with the entire school student population attending the event (with a view to motivate everyone to do better). MI members get directly involved in the process of selection of beneficiaries which establishes a long term bond. Additional School –specific support is provided on need basis. Efforts are also made to connect interested corporates and other well-wishers through long term sponsorships.

Due to Covid restrictions during academic year 2020-21, only beneficiary students were called to receive their awards and scholarships. A total of 562 students were given cash awards and merit-cum-means scholarships.



## **Open Scholarship Initiative**



This flagship initiative covers the largest number of beneficiaries and typically connects over four thousand students and their families to MFT. Scholarships are open to bright and needy students from Class 8th, all the way up to completion of the first degree. Continuity and support, personal assessments by members and volunteers (through house visits) and annual on-the-spot re-assessments are key features of this initiative.



Beginning with fewer than hundred students in 2004, the scheme now caters to close to 4000 students. Every year on the spot re–assessments are done for all old beneficiaries while new applicants are given scholarship based on household visits and personal assessments by esteemed Members and Volunteers.

This year due to Covid restriction, almost all the assessments have been carried out through video calling. This was an eye opener for all our members and volunteers. Year 2020-21 was an exception and observations during due diligence and reassessment were really alarming and heart wrenching.

Schools and colleges were closed most of the time during this year. The physical classroom method was replaced by online teaching. But it required every student to have a digital gadget, at least a smartphone, for online studies. This was an extra expense in addition to regular tuition fees. Monetary resources of most of

our beneficiary families have reduced considerably due to loss of job, closure of small businesses, temporary layoff, substantial cut in salary, etc. Over and above, medical expenditures have increased in most cases. So, it was a double whammy for these families and MFT support was very timely and useful.

Scholarship disbursements are usually carried out over twelve to fifteen well-organised events where students (and parents) are apprised of the wide range of MFT initiatives. Each event typically covers 200 to 300 students. Samvedana is an integral part of these events and leads to additional support through distribution of clothes, toys, household items, notebooks etc. Further, efforts are made to motivate students to realize their inherent potential, work hard and do better. This year, due to Covid restrictions, we carried out this program online in the form of webinars. During 2020-21, a total of Rs. 1.29 crore were distributed to 3800 students under this Open scholarships initiative.





A new scheme of Shining Stars and Stars has been launched last year with a view to provide greater financial support and mentoring to the very bright and promising students from amongst the large number of beneficiaries. The scheme not only provides higher, need-based financial support but it also connects each student to a specific mentor on one-to-one basis. A total of 84 such Shining Stars and Stars were identified this year for higher scholarships.

A total of 89 laptops/Desktop/tablets and more than 100 smartphones were distributed. Smartphone initiative continues to make good strides, thanks to generous contributions by esteemed members, associates, and well-wishers!!! Sincere gratitude to each one of them.

## **Asha Deep**

In many ways, Asha Deep street-to-school initiative has become MFT's most well known project in the city. These street schools literally take education to the door steps of children who otherwise would be out of the formal education system. These 18 schools are run on footpaths, under flyovers and in slums etc. Close to six hundred children are enrolled in Asha Deep centres that run on an average of 2 to 3 hours daily. Smart uniforms, shoes, school bags etc are provided to ensure that children indeed take pride in being a part of these "schools". Nutritious snacks are given every day and an effort is made to ensure all-round development of these children. Saturdays are devoted to extra-curricular activities; painting, arts & crafts are encouraged and all festivals as well as national days are celebrated.

An Annual Sports Day is organised where all 600 children get to compete in various sporting events. Performances by Asha Deep children always draw a standing ovation during Annual Cultural Evenings and these children are frequently sought after by a number of other city based organisations to participate in various events.

All Asha Deep children are also enrolled in regular schools and selected, bright students are specially coached at Asha Deep Mentor-Sponsor initiative neat Sursagar. Other promising students are enrolled in Navprerana, a special initiative of Navrachana Education Society.

Asha Deep schools have indeed become a darling of the citizens of Baroda who see them as a unique example of societal commitment for the under-privileged – something that citizens of this Sanskarnagari can take pride in! Citizens indeed love to share their joyous occasions with the children by bringing family and friends over for the celebrations!







## **Asha Deep Mentor-Sponsor**

As part of a comprehensive strategy, very bright Asha Deep students (87 of them) are being carefully coached and groomed in specially developed and very aesthetic Asha Deep Mentor Sponsor Centre near Sursagar. This initiative has formal education for children of first to eighth standards, with a student—teacher ratio of 10 to 1, to ensure individual development of the child. Children can come and go hands-free and all-round development is given due weightage. Catching them young is indeed the foundation stone of this initiative.

Due to Covid restrictions, physical classes remained suspended for almost full year. Teaching shifted to online mode. It was a new and challenging task for everyone and our team of teachers have done their best to impart education through this method. Many students could not attend these classes regularly due to unavailability of smartphone in their families at the time of teaching sessions.

## Project Kayakalp

Project Kayakalp, aimed at transforming lives of bright and needy students of standards 9th to 12th, with both schooling (in the morning) as also Kayakalp activities taking place at Baroda High School, Danteshwar. This was a long-cherished dream and was made possible through detailed discussions and signing of an MoU with Baroda Lions Club Education Trust (BLCET) who run four highly regarded schools in the city. Of these, Danteshwar campus is located in and focusses on socio-economically weaker sections of our society. BLCET specially took permission to start science stream at the school last year. Both, 11th and 12th Science are now operational.

In addition to transporting the students from various parts of the city, sumptuous & nutritious lunch is also served right after morning school (and before Kayakalp activities). A total of 158 students are part of Kayakalp now. As per Kayakalp charter, a lot of emphasis is placed on nurturing values, personality development, communication skills, life skills & spoken English, etc.

The physical classroom method was replaced by online teaching due to Covid restrictions. Both, teachers and students, have made extra efforts to learn and adjust with new ways of teaching. So, there was no interruption in studies in Kayakalp due to Covid. MI ensured that all students should have independent smart phones to avoid any disturbance in studies. Our Smartphone Initiative was very helpful to overcome this challenge.

No final board exams were conducted this year and students were mass promoted. Kayakalp result was 100% and a number of Kayakalp students have excelled with top rankings in their respective schools. Mastercard teams from Vadodara, Pune, Bangalore and Gurugram have conducted very effective and interesting online sessions for Kayakalp students throughout the year on various topics like Vedic Math, Aptitude test, Career counselling, Hobby Development, Communication skills, Internet usage and control, Importance of Social service, etc.

We have instituted Shyam Sundar Choudhary Memorial lecture series in fond memory of Late Shri Shyam ji, who was a leading businessman and a philanthropist from US. Being a MI member, a well-wisher and a great human being, he had established a close connect with MFT in general and with Kayakalp in particular.

The first virtual lecture in this series was delivered by Ms. Tejal Amin, a well know personality of Vadodara, on Value Based Education. She focused on multidimensional approach to impart holistic education. Students' interaction and question answer session stole the show. Shri Avadhoot V Sumant, a leading advocate in Vadodara, delivered second lecture in this series on 'The life in law is the law in life'.









## **Humanitarian Initiatives**

Last two years have seen unprecedented humanitarian crisis in the form of Covid 19. Corona virus resulted in a crisis of survival for many marginalized families. MI/MFT supported students of Asha Deep, ADMS and Kayakalp and their families. Later, coverage was extended to all needy beneficiaries. Ration kits and other necessities were distributed to over 3000 families. Large number of fruit packets as well as masks and gloves were provided to Corona warriors and workers. Ration kit distribution continued round the year as an effort to support beneficiaries and other needy members of the society. Special Migrant Labour initiative was launched to help these workers reach back home safely. More than 2500 such families were taken care of under this.



## Annual Cultural Evening

Annual Cultural Evening, organized every year in a large auditorium, gives an opportunity to our beneficiary students to showcase their talent in different forms of performing arts — music, dance and theater. Competitive team performances are presented by our adopted schools and special performances are given by Ashadeep, ADMS and Kayakalp students. Each year there is a theme that facilitates delivery of multiple meaningful social messages through various performances. We also share details of our activities and initiatives taken during the year. These evenings regularly find a very large audience with the auditorium capacity overflowing. However, due to Covid restrictions, the event could not be organized this year.

## **Annual Sports Day**

Annual Sports Day is organized every year at Billabong High International School for more than 600 students from ADMS & 18 different Asha Deep centers. Multiple sports competitions conducted this day serve as a platform for hidden and budding sports enthusiasts to find their footing. The excitement and enthusiasm of these Children is indeed contagious. Selected Asha Deep teachers are also recognized & honored at this event. All the students are provided with welcome drink in the beginning and meal after the events. Large number of MI members and other well-wishers attend this event to motivate the students. Again, owing to Covid-19 restrictions, this event also could not be conducted this year.





In Krupa Gandhi's house, having the next meal depended upon the number of agarbattis her father managed to sell door to door. For Dharmesh Vankar, dropping out of his 8th standard was the only option, since his pedal rickshaw driver father couldn't afford the fees.
